AMERICA'S HISTORY

The United States of America was founded as a Democratic Republic.^{1, 2, 3} A government by the people, for the people, following a constitution. However, in our infancy, our land and people were strictly a union of 13 individual colonies, and still beholden to Great Britain's rule. In the late 1700's, members and leaders of the 13 colonies agreed to form a central government declaring their Independence from Britain, desiring to break from Britain's tyrannical rule over them. These Patriots agreed they would take on the responsibility for issues the colonies could not resolve on their own in order to form a more perfect Union. Much of the issues they debated centered around commerce, trade, and debt.

Members from the thirteen American colonies sent Patriots to meet on their behalf, be their voices, and act in unison to revolt against the tyrannical rule of Great Britain. In the summer of 1776, the Continental Congress met in Pennsylvania and made the clearest call for Independence. They resolved that the colonies ought to be free from Great Britain and move forward as individual states, and that all political connections between them and Great Britain should be completely dissolved. After multiple edits, this written resolution was called the Declaration of Independence and was signed on July 4th, 1776. This formal revolt led to the American Revolution, also known as the Revolutionary War [1775-1783].⁴

THE DECLARATION OF INDEPENDENCE

The Declaration of Independence contains the vision for our country, the complaints against the King, and the reasons why colonists wanted to be free from British rule. It states that People have certain Inalienable Rights including Life, Liberty and the Pursuit of Happiness. All Men are created equal. Individuals have a civic duty to defend these rights for themselves and others.

Formally, the Declaration of Independence states, "We hold these Truths to be self-evident, that all Men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the Pursuit of Happiness. That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, — That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness...When a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security."⁵

THE UNITED STATES CONSTITUTION

American Patriots knew in order for them to survive this battle with Great Britain, claim independence, and triumph against oppression, they had to UNIFY under the same banner of beliefs. It was at that time, work was underway to formally structure this government [1778-89]. The United States was formed as a result of the American Revolution. After the war ended, Patriots wrote the U.S. Constitution [1789] forming a new government, and describing its powers. These thirteen colonies became the first thirteen states as each signed off on the agreements written in the Constitution.⁶ Using the Bill of Rights, the Constitution defines our freedoms (ie right to free speech, freedom of religion, and the right to bear arms, etc), limited government, and the rule of law.⁷

America needed a leader, a voice for our government and our people. On April 30, 1789, George Washington, standing on the balcony of Federal Hall on Wall Street, NY, became our 1st president [1789 to 1797]. This was more than ten years after the signing of the Declaration of Independence [1776].⁸

Although American patriots made great strides in bringing our nation together, the cost to run the war was very great. In the infancy of our nation, Congress had no power to collect taxes from their people and no capital to secure funds from foreign entities or other governments. In 1775, in order to address this problem, Congress chose to issue paper money in the form of bills of credit as good faith promising coins to repay the debt created by the war. Congress also started collecting money from the colonies in order to create a government fund in which to pay for the war.

In order to finance the debt these new United States had to issue notes (money on paper / corporate indebtedness), and those notes were bought up by the British Empire. The United

States has been in debt to Europe ever since. The powers that control this empire was the result of a union between British royalty, the East India Company, and other infant global businesses.

THE UNITED STATES TREASURY

In order to manage our growing debt and financial concerns between colonies, on February 17, 1776, Congress appointed a Committee of Five to oversee this fund and called it the Treasury. It was reorganized a number of times and endured the collapse of the value of a dollar. In 1789, The United States Treasury was formed as a way to solve the new nation's debt service problems (largely war debt). Alexander Hamilton was appointed by George Washington to serve as the first Secretary of the Treasury from 1789 to 1795. Hamilton was in charge of the financial health of the states.^{9,10,11}

George Washington and the Framers were successful from breaking free from the tyrannical world power of Britain. This freedom was short lived because ultimately, they could not afford the financial debt of their independence.¹²

THE ROTHSCHILD BANKING CARTEL

Having already learned that there were huge financial gains to be made from catastrophe [Napoleonic Wars of 1815], the Rothschild family and it's United States affiliates (J.P. Morgan, John D. Rockefeller, E.H. Harriman, and others) conspired to help create the next catastrophe, the American Civil War [1865].¹³ They understood that a war could be fought over the issue of slavery, which was the issue of the day for our nation. Because they controlled the banking, railroad, and gas/oil industries, they knew they could supply the infrastructure for the war machine and ultimately finance that war machine driving our Nation further into debt.

Similar to financing the debt to the Revolutionary War, America could not pay the debt of the Civil War and had to once again issue money on paper to finance the debt. We are taught to believe that the "British Empire" has collapsed and that the greatest colonial power in the world has shrunk to 1/100th of its former size. That is in fact not the case. The "British Empire" is as large as and more powerful than it has ever been. It has given up the illusion of control, but retains ultimate control as it holds the debt of innumerable countries across the globe.

THE 13th and 14th AMENDMENTS

Immediately following the American Civil War [1868], the 13th and 14th Amendments to the Constitution were written.^{14,15} The original writing of the 13th Amendment to the Constitution, tried to prevent American citizens from receiving titles of nobility from Britain. The rewriting covers the more benevolent issue of slavery. The 14th Amendment to the Constitution, in contradiction to what the Founding Fathers had intended, took more power away from the states, by dictating that citizens were members of a Federal government, instead of citizens of individual states. The 14th Amendment was never ratified by President Johnson, and is in direct violation of the Constitution. Because the 14th Amendment was not ratified, we are in fact not really Federal citizens. That is

part of the illusion of why we have to listen to the Federal government and the states believe they are powerless to effect change at a national level. In reality, the states have power, and we as citizens have power of which we are unaware.

WHY WE ARE HERE: THE UNITED STATES OF AMERICA, CORPORATION

In 1871, the District of Columbia Act was passed illegally.^{16,17} It is considered to be “the single most tyrannical act” against the Constitution and American citizens.¹⁸

“With the passage of the District of Columbia Act of 1871, the Constitution *for* the United States of America was officially changed to the CONSTITUTION *OF* THE UNITED STATES OF AMERICA (all caps). The name of the country, as written on all legally binding documents, was changed from the United States of America to the UNITED STATES OF AMERICA (all caps). What this did, (are you ready for this one), is transformed the country into a CORPORATION under the control of the British monarchy, and each and every citizen of the Republic then became a Corporate Vessel with a monetary value, under the ownership of the corporation. We were no longer seen as people, but rather we have been used as debt instruments against the overall debt of the U.S. corporation, whereby a trust fund was (and still is) set up in our names upon the time of our birth when our mother signs off on our birth certificate. Our social security number is used as a means of setting up ten separate and distinct trust funds under the auspices of the U.S. corporation. The District of Columbia, i.e. Washington, D.C., became a completely separate entity unto itself, which became the head of this corporation. In effect, the Constitutional Republic was given a sleeping pill, and in its place was formed a CORPORATION ultimately under the control of the British Monarchy and the Rothschild banking cabal. All that we had fought for one hundred years earlier as part of the American Revolution was falsely shoved aside into the waste bin with the stroke of a pen. From this point forward, each and every single member of Congress, the House of Representatives, and the U.S. President swore an allegiance not to the Constitutional Republic, but to the CORPORATION of the UNITED STATES OF AMERICA. This effectively labels them as traitors to the Republic and to the people of this nation, as this system of tyranny remains intact to this very day. In effect, the ‘government’ became the overseers of Corporation U.S.A.”^{19,20}

The CORPORATION OF THE UNITED STATES OF AMERICA, created through the Act of 1871, is a foreign owned entity that is NOT based on the Constitution, which is why the government seems to ignore the Constitution from time to time as is convenient.^{21,22,23, 24} This is similar to the Vatican in Italy.^{25, 26} In 2020, you may be surprised to learn that the United States, as we know it currently, is actually a corporation, indebted to Britain. Well, what happened to our Independence? This is why the Rothschild Banking families and conspiracy theories are in the

news constantly. Our sources include an article that is an excerpt from a book that outlines the Revolutionary War as a sham, and describes more smoke screens about money, power, and control. The revolutionary war is popularized as a fight about taxation without representation. After all, whoever has control over commerce controls one's profit and the economy.^{27, 28, 29}

All wars are why the US is \$27 trillion dollars in debt and climbing. Wars are expensive and need to be financed. Ultimately, they are fought to create more financing. Ask yourself, why are we always at war, when recently the wars seem to yield no result whatsoever.

Because debt service and compound interest is a killer, the U.S. was and is always spending beyond its means. Therefore, the government needed a more flexible way to overspend and thus created the Federal Reserve.³⁰

THE FEDERAL RESERVE

"The Federal Reserve Act of 1913 established the Federal Reserve System as the central bank of the United States to provide the nation with a safer, more flexible, and more stable monetary and financial system. The law sets out the purposes, structure, and functions of the System as well as outlines aspects of its operations and accountability. Congress has the power to amend the Federal Reserve Act, which it has done several times over the years. The complete act, as amended, is provided" in our resources.^{31,32}

When you read or hear things like "more flexible policies" think of new rules and paper money. The Federal Reserve is not money on the 'gold standard'. The Federal Reserve is money on paper and more indebtedness (ie. CONTROL). The US Treasury is based on the 'gold standard'. Real value. Real money. If we continue to operate under the Federal Reserve we will never escape our indebtedness to the European Bankers.

WHERE WE ARE GOING: PATRIOTS AT WORK

America's current financial system is corrupt and keeps a small number of global people in control of the masses through debt, as such, no one under that debt is truly free. There is a silent, sinister force and purpose behind the CORPORATION OF THE UNITED STATES OF AMERICA, the Federal Reserve, and the structure of continual indebtedness. At the same time, there is also a positive force that has been trying to enact change and bring an end to the current corrupt system.

Donald J. Trump was recruited by that positive force to help bring about global change and an end to the sinister forces behind global debt. Federal Reserve under the US Treasury, and put the U.S. back on the 'gold standard.' The Federal Reserve must now gain the US Treasuries approval to act on behalf of the people.^{36, 37, 38, 39}

President Donald J. Trump is in the process of dissolving the CORPORATION of the UNITED STATES OF AMERICA, which ends with 'the greatest first term presidency ever.'⁴⁰ Trump will also be the LAST president of the CORPORATION of the UNITED STATES OF AMERICA.
